



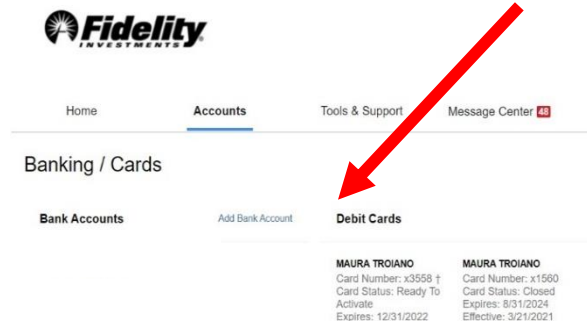
# How to Set-up Direct Deposit for Flexible Spending and Reimbursement Accounts




## ADD A BANK ACCOUNT

You can add your personal bank account to receive your reimbursements via direct deposit from your flexible spending and reimbursement accounts by accessing [NetBenefits](#). Select the Flexible spending and reimbursement accounts tile and then select **Link to bank account**. Adding your bank account will allow you to quickly reimburse yourself via direct deposit for eligible health care, dependent care, and other flexible spending and reimbursement accounts expenses paid out-of-pocket by you or your eligible dependents.

Select **Add a bank account**.



The pop-message for **Add Bank Account** will display. Enter your banking information. Note important tips below.

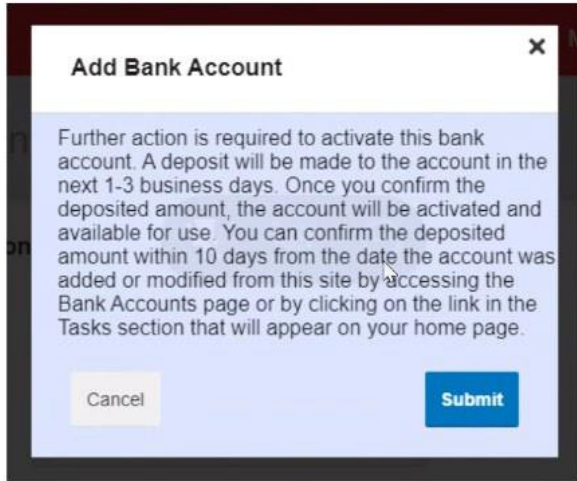
## IMPORTANT TIPS:

- The bank account must be in your name and social security number. The real-time banking verification process helps ensure that your name, social security number, bank name, and account number is a match.
- The bank account must have a positive balance at the time of verification.
- The bank account cannot be a prepaid debit card account, home equity line of credit, line of credit, or credit card check.
- The bank account cannot be in a negative status, frozen status or be a closed account.
- The bank address should be the corporate headquarters address and not a branch location; in many instances, the address will auto-populate.



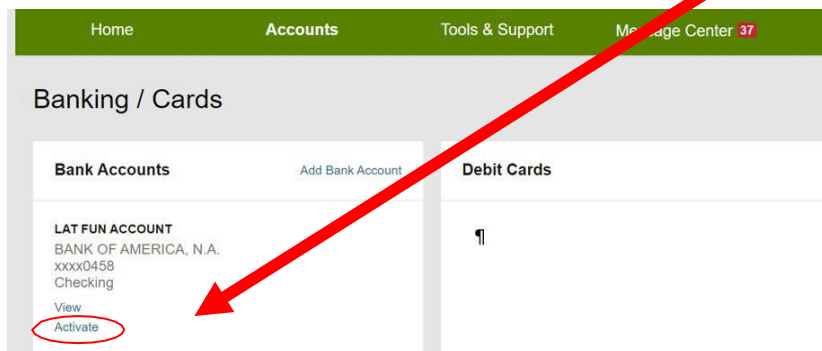
## MICRO-DEPOSIT VERIFICATION

If your bank account can't be linked based on information provided from the real-time banking verification process, then you can verify your account using the micro-deposit verification process.



**IMPORTANT:** For security purposes, a micro-deposit ranging from \$0.01 - \$0.99 will be made to your bank account in the next 1-3 business days by **"FIDELITY INVESTM PRETAX BENEFIT TRANS"**. You will receive an email reminder to check your bank account for that Fidelity micro-deposit in your account. Once you see that micro-deposit in your account, make note of the amount.

Log in to NetBenefits and select **Flexible spending and reimbursement accounts** tile, then **Link a bank account**. The notification will read **"One or more bank accounts require activation."** Select **Activate** and enter the micro-deposit amount that was deposited in your bank account and then select **Submit**. You will receive a notification that a new bank account connection has been added to your flexible spending and reimbursements accounts.



You will now start receiving your reimbursements faster via direct deposit to your own bank account.

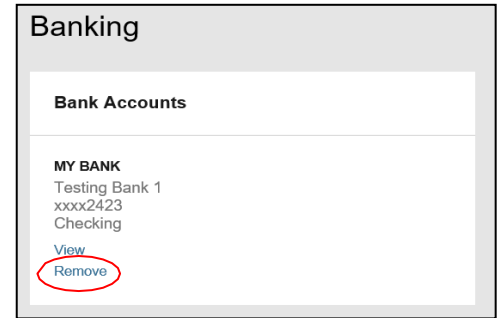

## REMOVE A BANK ACCOUNT

To remove a bank account, go to [NetBenefits](#). Once logged in, select Flexible spending and reimbursement accounts, then select **Link a bank account**. Underneath the account will be the option to View or Remove. Select **Remove** to eliminate the selected bank account.

**Note:** The **Remove** button will only be visible when bank account updates are allowed and if there are no pending electronic transactions.
